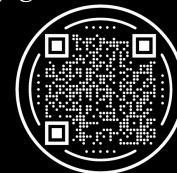

The Suffolk County Sheriff's Office is the oldest law enforcement agency in Suffolk County and the only law enforcement agency to have county-wide jurisdiction. Some of the Office's responsibilities include:

- Operating two correctional facilities and providing county courthouse security
- Patrolling and investigating all crimes committed on county-owned property
- Pistol permits for the five East End towns of Suffolk County
- Specialized units including K-9, DWI Enforcement, Marine Patrol, Dive Team, ATV Unit, Sheriff's Emergency Services Unit (ESU), Air Support Unit, and a tactical entry weapons team

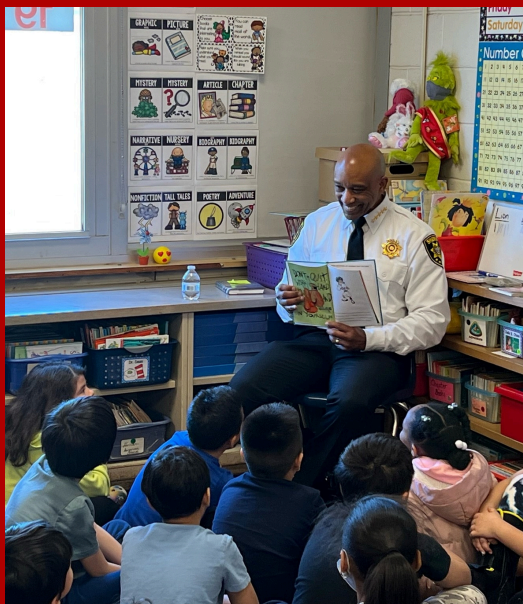

## HIGHLIGHTS

### CORRECTIONS INTELLIGENCE CENTER

Launched in April 2023, this center is the first-of-its-kind jail intelligence network that shares data, trends, best practices, and potential threats across jails and prisons - thwarting crimes to create safer communities.

### SATI HUMAN TRAFFICKING UNIT

Since its inception in 2018, the Sheriff's Anti-Trafficking Initiative has led to the successful prosecution of numerous human trafficking and other criminal networks, while helping the victims to reclaim their lives.

### START RESOURCE CENTER

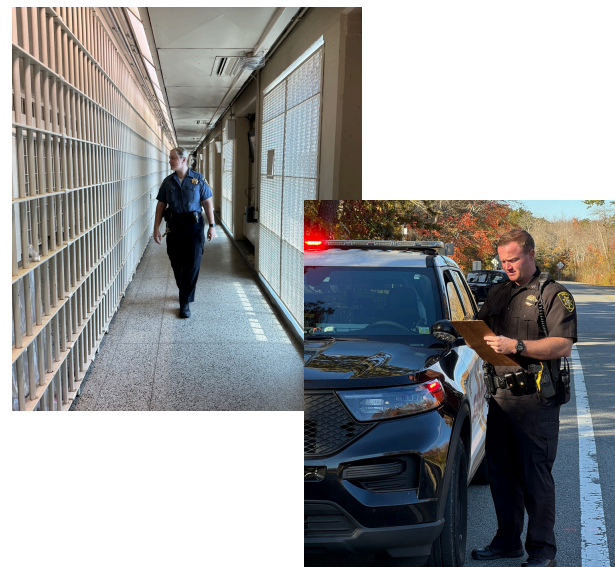
The START Resource Center provides assistance to current and former inmates as they transition back into the community, whether they were incarcerated in Suffolk County or are returning to Suffolk after incarceration elsewhere.

### SHERIFF'S ADDICTION TREATMENT PROGRAM

The SATP Program is an intensive substance abuse treatment initiative designed for incarcerated individuals with a range of criminal charges, all of which correlate to their substance use disorders.

## CORRECTIONS DIVISION

The Corrections Division of the Suffolk County Sheriff's Office oversees the Correctional Facilities in both Riverhead and Yaphank with a maximum capacity of 1,816 inmates. Correction Investigators inside the jails work in Internal Security, the Gang Unit, and the K9 Unit. Correction staff also run the Corrections Intelligence Center, the Start Resource Center, and the Human Trafficking Unit.



## POLICE DIVISION

The Police Division of the Suffolk County Sheriff's Office handles all civil matters for the court system, including serving Extreme Risk Protection Orders (ERPO), evictions, outstanding warrants, and domestic violence issues such as orders of protection. Deputy Sheriffs also patrol the county's roadways and waterways, search for impaired drivers as part of the DWI Enforcement Team, and handle all transportation of inmates
